• In France:

- two (2) academic semesters from January to December with 60 ECTS including a master's thesis.
- six (6) months professional experience (internship) in France or abroad, acknowledged as an equivalence from ESC Clermont (need the school to approve the topic/project)

Advantages & Requirements

Advantages of Clermont for Foreign (Chinese) students:
